Frequently Asked Questions

Q: How can I receive therapy services?

A: Once therapy has been notified, or the need for therapy identified, the therapist will obtain a copy of your medical insurance cards and an order from your doctor. Functional Pathways will then verify your insurance coverage and notify you or your Power of Attorney (POA) of your financial obligation prior to completing the initial evaluation. A billing packet will be provided to you or your POA for signature and will need to be returned. However, we are able to initiate therapy services with a verbal consent from you or your POA. Once a physician's order has been obtained, insurance verified and consent for treatment has been given, the therapist will proceed with the initial evaluation and recommend a plan of care.

Q: Why did I receive a bill from Functional Pathways?

A: When insurance is verified prior to initiating therapy, you are notified of any financial obligation that may be accrued if your insurance doesn't cover 100% of your therapy or if your deductible has not been met, etc. Functional Pathways will submit all therapy claims to insurance at the end of each month that the services were provided. It may take several weeks for your insurance company to settle claims submitted for therapy, and therefore, you may receive your bill for therapy several months after services were rendered.

Q: How often will I get therapy?

A: Prior to beginning therapy, our therapists will discuss your treatment plan and expectations based on your clinical need. Your treatment plan is individualized and specific to you. Each treatment session will vary in frequency according to your medical needs and the length of your session depends on the goals you and your therapist are addressing.

Q: Once I start therapy, how long will it last?

A: Your therapy plan will be individualized and customized for you depending on your current functional status, meaning what you can functionally do for yourself, compared to what you were doing before this decline. Each medical condition affects people differently and your therapist will create the goals in your plan of care accordingly.
